


At the core of our social impact approach is people. We empower our engineers to engage in academic events, and community initiatives that promote learning, collaboration, and positive social impact.



Through ongoing efforts to improve efficiency and reduce emissions, we have achieved a steady decrease in our CO₂ equivalent emissions, going from 37.5 to 21.3 ton CO₂eq / USD million revenue over the past three years.


